A Snapshot

Roads Australia, a not-for-profit association, is the national peak body for road sector stakeholders.

Its members comprise most of the significant players in the Australian road sector, including major civil construction companies, government agencies, industry associations and unions.

Roads Australia has two main objectives – to bring the stakeholders together and to influence policy. It seeks to do the latter, not through lobbying, but by working "inside the tent".

Roads Australia has policy chapters covering sustainability, congestion, capacity and road financing. Participation in these chapters provides the opportunity to contribute to policy as it evolves and to network actively with other industry participants. Individual policy chapters have up to 120 members.

Annually, Roads Australia holds some 40 events, attended by more than 2,500 industry members. These networking events include conferences, workshops, large lunches and small single table functions with senior policy makers.

Roads Australia's two largest networking activities are the Annual Summit and the Forum of industry leaders held every six months to review the state of play for national roads related issues and activities. These events are attended by some 200 industry representatives from about 80 companies and organizations.

Roads Australia also publishes a fortnightly email newsletter, RA Insider, which provides an easy news summary of what's happening in the roads industry. It has become the accepted industry mechanism for information of this kind and is now received by almost 3,000 senior managers across Australia.
