EVENT SUMMARY

There are over 200 former landfills in Victoria, many of which are within the greater metropolitan area and in close proximity to residential areas. Many of these sites present challenges in managing risks to community and the environment. This seminar will examine the post-closure requirements for landfills to provide an opportunity to learn more about obligations and responsibilities and to discuss concerns and opportunities with regulators and government representatives.

This topic has a particular focus within the planning and environment industry in response to the Cranbourne landfill incident in 2008, and the recently released Victorian EPA guidelines on closed landfill sites. (see link - <http://www.epa.vic.gov.au/your-environment/waste/landfills/closed-landfills>).

The new EPA guideline requirements are designed to improve landfill aftercare and to provide greater assurance that environmental risks of closed landfills are appropriately managed. The management of closed landfills will involve the use of EPA appointed Environmental Auditors, in a similar way to operating landfills, through the use of 'post closure' Pollution Abatement Notices.

The workshop will focus on closed landfills and provide information (and generating discussion) on:

- Obligations for owners and operators of landfills and former landfills.
- Application of newly released EPA Closed landfill guidelines.
- Legal, technical and policy aspects of the new guidelines.

Mark will be presenting on the legal obligations of compliance with Pollution Abatement Notices, the EPA's new approach to compliance and enforcement and other legal aspects of the new guidelines.
